The Council of the Rural Municipality of Frenchman Butte No. 501 in the Province of Saskatchewan enacts as follows:

- 1. Sanitation services consisting of bi-weekly pick-up of household garbage will be provided to the residents of the Organized Hamlet of Frenchman Butte.
- 2. A fee of \$110.00 will be assessed each year for each dwelling or other building, including a trailer that will have the benefit of the sanitation services.
- 3. Any amount assessed, that remains unpaid at the end of the year in which the service was provided, shall be added to the taxes on the property and collected in the same manner as taxes.
- 4. Bylaw 2018-08 is hereby repealed.
- 5. This Bylaw comes into effect on January 25, 2023.
