THIS AGREEMENT made in triplicate this 6th day of
December, 1983;

BETWEEN: Mary Buchta and Marion Buchta, both of the Hamlet of
Frenchman Butte, in the Province of Saskatchewan,
representing the Anglican Church Women of Frenchman Butte,
and

Vera Jarvis and Margaret Young, both of the Hamlet of
Frenchman Butte, in the Province of Saskatchewan,
representing Branch 76, Pensioners and Senior Citizens
Organization.

Of the First Part.

AND: The Rural Municipality of Frenchman Butte, No. 501, of
the Village of Paradise Hill, in the Province of
Saskatchewan, a Municipal Corporation.

Of the Second Part.

WITNESSETH:

WHEREAS the Parties of the First Part are the owners
of Lots One (1) and Two (2), in Block One (1), in the
Townsite of Frenchman Butte, in the Province of Saskatchewan.

AND WHEREAS the said owners have deemed it expedient
that the said property be owned and held in trust by a
public body for the use of the community and members of
the said Anglican Church Women of Frenchman Butte and
Branch 76, Pensioners and Senior Citizens Organization.

NOW THEREFORE on behalf of the said Anglican Church
Women of Frenchman Butte and Branch 76, Pensioners and
Senior Citizens Organization, hereby request The Rural
Municipality of Frenchman Butte No. 501 to accept the
transfer of the title to the said property in trust and to
hold the said title in trust in the name of the said
Municipality until such time as the duly elected officers
of the said Anglican Church Women of Frenchman Butte and
Branch 76, Pensioners and Senior Citizens Organization
may direct otherwise.

THE PARTY OF THE SECOND PART hereby agrees to accept
the transfer of title to the said property and to hold the
said property in trust in the name of the said Municipality
until such time as the duly elected representatives of the
said Anglican Church Women of Frenchman Butte and Branch 76,
Pensioners and Senior Citizens Organization may direct
otherwise.

The PARTIES OF THE FIRST PART agree that no part of
the cost of operation shall fall on the Municipality and
they also agree that each of their organizations shall
contribute a fair share to the maintenance and upkeep of
the building situated on the said lots and the members of
each organization shall have the right to use the building
mentioned above at mutually agreeable times.
