

BYLAW NO. 53

A BYLAW OF THE RURAL MUNICIPALITY OF FRENCHMAN BUTTE NO. 501, to provide for the entry, by the Municipality, into an agreement with the FORT PITT WAR MEMORIAL HALL CO-OPERATIVE ASSOCIATION LIMITED, and the FORT PITT MEMORIAL CLUB.

The Council of the Rural Municipality of Frenchman Butte No. 501 enacts as follows:

1. That the Municipality enter into an agreement with the Fort Pitt War Memorial Hall Co-operative Association Limited and the Fort Pitt Memorial Club for "In Trust" ownership by the municipality, of the following property:

All that portion of the North West quarter of Section Two (2) in Township Fifty-Four (54), in Range Twenty-six (26), West of the Third Meridian, in the Province of Saskatchewan, Dominion of Canada, more particularly described as follows:

Commencing at the South West corner of the said quarter Section; Thence Northerly along the West boundary two hundred and forty-two (242) feet; Thence Easterly at right angles to the said west boundary one hundred and eighty (180) feet; Thence Southerly parallel with the said West boundary to the South boundary; Thence Westerly along the said South boundary to the point of Commencement.

2. The Reeve and Administrator of the Rural Municipality of Frenchman Butte No. 501 are hereby authorized to sign and execute the attached agreement identified as Exhibit A.

"EXHIBIT A"

This Agreement made in triplicate this 5th day of May, 1988:

**BETWEEN:** Fort Pitt War Memorial Co-operative Association Limited,  
of the Postal District of Frenchman Butte,  
in the Province of Saskatchewan.

Of the First Part.

**AND:** Fort Pitt Memorial Club,  
of the Postal District of Frenchman Butte,  
in the Province of Saskatchewan.

Of the Second Part.

**AND:** The Rural Municipality of Frenchman Butte No. 501,  
a Municipal Corporation,  
in the Province of Saskatchewan.

Of the Third Part.

**WITNESSETH:**

WHEREAS the Party of the First Part is the registered owner of the following property:

All that portion of the North West quarter of Section Two (2) in Township Fifty-Four (54), in Range Twenty-six (26), West of the Third Meridian, in the Province of Saskatchewan, Dominion of Canada, more particularly described as follows:

Commencing at the South West corner of the said quarter Section; Thence Northerly along the West boundary two hundred and forty-two (242) feet; Thence Easterly at right angles to the said west boundary one hundred and eighty (180) feet; Thence Southerly parallel with the said West boundary to the South boundary; Thence Westerly along the said South boundary to the point of Commencement.

AND WHEREAS the said owner has deemed it expedient that the said property be owned and held in trust by a public body for the use of the community and members of the Fort Pitt Memorial Club.

NOW THEREFORE in consideration of the terms and conditions of this agreement, the parties agree as follows:

1. The said Fort Pitt War Memorial Co-operative Association Limited, hereby requests the Rural Municipality of Frenchman Butte No. 501 to accept the transfer of the title to the said property in trust and to hold the said title in trust in the name of the said municipality until such time as the duly elected officers of the Fort Pitt Memorial Club may direct otherwise.
2. THE PARTY OF THE THIRD PART hereby agrees to accept the transfer of title to the said property and to hold the said property in trust in the name of the said Municipality until such time as the duly elected representatives of the said Fort Pitt Memorial Club may direct otherwise.
3. THE PARTIES OF THE FIRST AND SECOND PART agree that no part of cost of operation shall fall on the Municipality and they also agree that their organizations shall provide for the maintenance and upkeep of the buildings and facilities situated on the said property; Further, they shall provide adequate insurance, including a minimum One Million dollars (\$1 000 000.00) liability insurance policy, and copies of the policies to be deposited at the municipal office.
