CONVENTION FOR ALL MUNICIPALITIES WAS HELD AND THE REEVE AND SECRETARY-TREASURER ATTENDED.

BRAND BOOKS WERE RECEIVED AND DISTRIBUTED.

AN EPIDEMIC OF BLACKLEG IN AREA - ALL ANIMALS THAT DIE HAD TO BE BURNT.

ASSESSMENT ROLL WAS ACCEPTED AND ASSESSMENT NOTICES WERE MAILED OUT. THEY THEN HELD A COURT OF REVISION FOR ALL APPEALS.

PLACED A BOUNTY ON PRAIRIE AND TIMBER WOLVES.

CEMETERY WAS DEVELOPED ON SW CORNER OF NW13-52-24-W3, NAMED THE EMMAVILLE CEMETERY.

BUILT AN OFFICE FOR \$249.80 AND BOUGHT A STEEL STORAGE CABINET FOR \$100 AND A TYPEWRITER DESK FOR \$10. IT WAS DECIDED NOT TO PAINT THE OFFICE INTERIOR.
